WHEREAS, that Ronald J. Monroe and Kathy Monroe are the owners of record real property at 55 Whiteview Road in the Town of North Greenbush, New York (more particularly shown on the Assessment Rolls of the Town of North Greenbush as 123.11-3-35); and

WHEREAS, that the property located at 55 Whiteview Road is not located within any sewer district; and

WHEREAS, there exists within the Town of North Greenbush the existing Winter Street/Whiteview Road Sewer District in the vicinity of the property; and

WHEREAS, that such property is experiencing the failure of an existing individual household septic system and a connection to the municipal sewer system can be achieved at a reasonable expense to the property owner and the cost and timing of the installation of a new septic system may be prohibitive, burdensome and excessive; and

WHEREAS, that the property owner desires to enter into an Out-of-District Sewer Use Sewer Agreement with the Town of North Greenbush whereby they can be considered an emergency "Out of District Sewer User" and be connected to the Winter Street/Whiteview Road Sewer District; and

WHEREAS, the property owner agrees to proceed through the formal Sewer District Extension process by no later than November 1, 2025, to cause the extension of the existing Winter Street/Whiteview Road Sewer District to include the subject property; and

WHEREAS, the Public Utilities Department has considered the circumstances and does not believe that granting this request would compromise the adequacy of service for existing users within the district and has recommended approval of this request and execution of an Out-of-District Sewer Use Agreement with Ronald J. Monroe and Kathy Monroe; and

NOW THEREFORE, IT IS HEREBY RESOLVED BY THE TOWN BOARD OF THE TOWN OF NORTH GREENBUSH, RENSSELAER COUNTY, NEW YORK, that the Town Board, acting for and on behalf of the Winter Street/Whiteview Road Sewer District, does hereby authorize the emergency sewer tie-in of the property owned by Ronald J. Monroe and Kathy Monroe, located at 55 Whiteview Road, Wynantskill, New York 12198 to the Winter Street/Whiteview Road Sewer District, upon the terms and conditions set forth above and contained in the Out-of-District Sewer Use Agreement, including all required permits and fees, and in particular the condition of proceeding with the formal Sewer District Extension process by no later than November 1, 2025; and

# RESOLUTION IN SUPPORT OF A FAST NY APPLICATION TO BUILD A 50 MW SUBSTATION TO THE RENSSELAER TECHNOLOGY PARK

WHEREAS, The Rensselaer Technology Park was approved in 1981, and was developed soon afterward, providing many jobs and services in the Town of North Greenbush; and

WHEREAS, Properties in the Rensselaer Technology Park have an assessed value of \$39,285,302, full market value of over \$305 million and provide property tax and PILOT payments in excess of \$2 million yearly to the Town of North Greenbush, its special districts and Rensselaer County; and

WHEREAS, The Rensselaer Technology Park has approximately 150 acres between Route 4 and Stone Clay Road which has been designated for high-tech research and manufacturing that is presently unused; and

WHEREAS, several high-tech and pharmaceutical companies have been interested in the unused site but could not get sufficient electricity at the site for their uses;

**NOW THEREFORE BE IT RESOLVED**, That the Town Board of the Town of North Greenbush supports the application of FAST NY funding, and construction of a 50 MW substation at the Tech Park, following Town zoning and planning laws and protocols.
